- **1.** TECO-SF can only authenticate documents issued by government entities in our consular district (Northern California, Nevada, and Utah). For Federal documents (e.g., FBI record checks), contact TECRO in Washington, D.C.
- 2.Regulations prevent TECO-SF from authenticating US marriage certificates documenting the marriage of Taiwan citizens to citizens of certain third countries. Please check the Bureau of Consular Affairs (BOCA) website for details.
- 3. Verify that the **English names**, **birth dates**, and **birthplaces** of all **relevant individuals** on the document **exactly match** the information on their **passport** (Taiwan passport if they are a citizen of Taiwan). - **TECO-SF does not provide translation services or check translation accuracy**. Applicants must provide a complete, word-for-word translation that matches the original document's format.
- Applicants may also choose to only authenticate the English original here and have the Chinese translation authenticated by a notary in Taiwan.
- * If registering a marriage/divorce in Taiwan, applicants must file with a local household registration office within 30 days of authentication to avoid late penalties.
- For questions on naturalization, residency, marriage/divorce registration, etc., please contact the Ministry of the Interior's Household Registration Department (From inside Taiwan: 1996; From overseas: +886-2-7750-5096).
- * Utah County (US) Remote/Video Marriage Certificates do not comply with ROC regulations and cannot be registered in Taiwan, even after formal authentication by this office. Contact the Ministry of the Interior for definitive clarification.
- Marriage to a national of a specific country (e.g., India, Thailand, Vietnam): You must first register the marriage in the foreign spouse's home country, undergo an interview at a designated ROC mission, and then register the marriage in Taiwan.
- Mainland Chinese spouse with U.S. residency: After passing the interview with our Immigration unit, the authenticated Chinese marriage certificate will be noted as "Interview Passed," allowing marriage registration in Taiwan.
- Mainland Chinese spouse without U.S. residency: The authenticated Chinese certificate will be noted as "Interview Pending." The Taiwanese spouse must then apply for the interview in Taiwan (with the National Immigration Agency).
- * The applicant for Death Certificate authentication must be the informant listed on the document, or provide proof of their relationship to the deceased (e.g., birth/marriage certificate, household registry).
