

# **2026 Ministry of Education Huayu Enrichment Scholarship (HES) Selection Guide for Indians**

We are pleased to announce the application period for the 2026 MOE Huayu Enrichment Scholarship (HES) will officially open on the **1<sup>st</sup> of February, 2026**.

The application deadline is the **17<sup>th</sup> of April, 2026**.

## **Purpose:**

The HES is funded by the Ministry of Education (MOE) in Taiwan. It is for encouraging and providing Indians with opportunities to learn Mandarin language in Taiwan, to increase the understanding of Taiwanese culture and society as well as to promote mutual understanding and interactions between India and Taiwan.

## **Award Value:**

A monthly stipend of NTD 28,000.(About Rs.80,000)

## **Program Duration:**

Huayu Enrichment courses for Indians will only include 3 and 6 months. We kindly ask you to select only these two options on the online platform.

The awarded duration of the HES is from the 1st of September, 2026 to the 31st August, 2027. If recipients fail to get to Taiwan for enrolment during the designated time, they will forfeit their right to retain their scholarships.

Scholarship funding will become effective on the date of the recipient's enrolment. Scholarship funding will end according to the scholarship's expiration date or if the scholarship is revoked.

**Eligibility:**

Indian applicants above the age of 18, who possess a senior high school diploma or above, have shown excellent academic performance, and are of good moral character are eligible.

Candidates with one of the following qualifications may not apply:

- Is an overseas Chinese student or a national of the R.O.C. (Taiwan)
- Is currently registered as a student at a Mandarin Language Centre or has sought a degree from a university or college in Taiwan.
- Has already received a HES or a Taiwan Scholarship in the past.
- Is an exchange student to Taiwan during the scholarship commencement period.
- Is currently receiving financial benefits from the Taiwan government or another educational institution.

**Date for Release of Selection Result:** 20 May, 2026

\* Please note that results will be published on TECC website and applicants will not be informed individually on their outcome.

**Date for Submission of Approved Admission Letter:** 30 June, 2026

Applications should apply to the Mandarin Language Centre of a Taiwan university and follow the university's regulations. Once admitted, the recipients should upload/ send a copy of Admission Letter to online application system for confirmation. Recipients who do not submit their Letters before 30 June, 2026 will be disqualified from the scholarship selection process.

**Application Form and Supporting Documents:**

On-line applications should include the following:

- A completed Application Form
- A copy of the applicant's Indian Passport or other documents that may verify nationality.
- A copy of the applicant's highest degree and academic transcripts (all certificates must be in English).
- A photocopy of the applicant's application to a Mandarin Language Centre in Taiwan.
- Two reference letters signed (\*we also accept applicants to send the letters via emails directly to the Committee at [India@mail.moe.gov.tw](mailto:India@mail.moe.gov.tw))
- A signed Terms of Agreement Ministry of Education Huayu Enrichment Scholarship Program (HES) Form.
- Language Proficiency Requirements
  1. Mandarin Chinese Proficiency:  
TOCFL (Test of Chinese as a Foreign Language) Level 1 (A1) certificate;  
**or**
  2. English Proficiency:  
✧ IELTS score of 5.0 above; **or**

- ✧ TOEFL iBT score of 35–45 or above, or pBT score of 450–477 above; **or**
- ✧ An official university/college/school transcript showing a minimum grade of 90 out of 100 for a program taught in English.

**Selection Procedure:**

Document review and personal interviews will be conducted. Preference will be given to an applicant studying in a Taiwan Education Center, with TOCFL certificate of A1 or IELTS 5.5 above.

**Notes: Convert your CGPA to GPA**

**GPA (4.0 scale) = (CGPA ÷ 10) × 4**

**EXAMPLE:** GPA = (7.8 ÷ 10) × 4 = 3.12

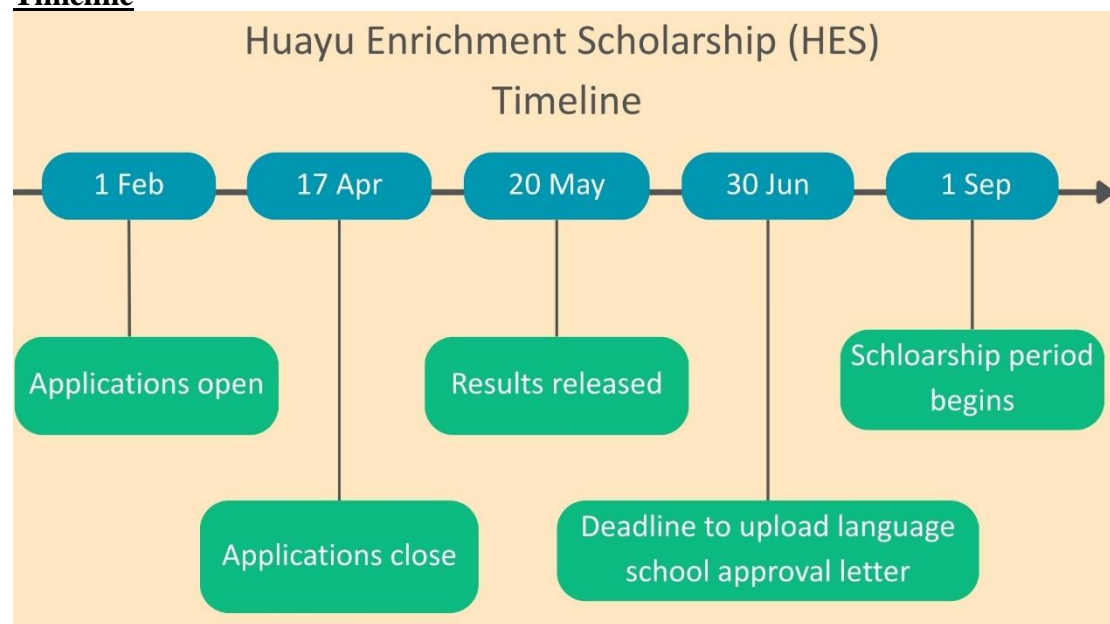

### **Terms and Conditions for Recipients:**

1. The recipient should undertake at least 15 hours of language courses each week. This does not include cultural visits, speeches, and other self-learning curriculum or activities.
2. The recipients are not allowed to apply to transfer to another Mandarin Language Center.
3. If the recipient concurrently accepts scholarship from other sources in Taiwan, he/she will lose their placement in the scholarship program. He/she will also have to return the funds granted for those months that he/she received multiple scholarships.
4. The termination and cancellation of a scholarship is based on regulations specified by each individual Mandarin Language Center. Mandarin Language Centers have the right to terminate or revoke a scholarship if the recipient's academic performance, moral character, or attendance record are not up to their standards.
5. Recipients should purchase student accident insurance and other relevant medical insurance. Insurance fees can be deducted by the Mandarin Language Centers from the monthly stipend before granting it to recipients.
6. Recipients are not allowed to work in Taiwan during the award period.
7. Recipients shall send reports with photos to Education Division, TECC in India, regarding what they have learned while studying in Taiwan and share their experience, for future reference and sharing on official social media platforms.
