Mosaic Taiwan is a fellowship exchange program for promising young leaders from the US and Canada hoping to gain firsthand experience of the Republic of China (Taiwan), providing participants the opportunity to better understand Taiwan's culture and society. This year's program will run from June 16 to 27. Participants will take part in teambuilding and leadership development exercises, as well as workshops, forums, and lectures on topics concerning Taiwan. There will also be visits to businesses and NGOs, as well as tours of scenic sites around the island.



Eligibility

- **US and Canadian citizens** between the ages of 20 and 35
- No previous travel sponsored by the R.O.C government to Taiwan
- Active interest in public affairs, politics, government, and international affairs

Applications

- Applications will be accepted from February 10 to March 12, 2025, by the representative offices of the Republic of China (Taiwan) in the United States and Canada (Taipei Economic and Cultural Representative Office, TECRO or Taipei Economic and Cultural Office, TECO).
- Interviews will be conducted by TECRO or TECO. Successful applicants will also be informed by their respective interviewing TECRO or TECO.
- A medical certificate will be required of successful applicants.
